F. Enrollment & Budget Report Karen - Principal

- a. We gained two students in December, and two more this week! We are on the upward trend.
- b. Budget is looking good. Still on track and preparing to purchase new curriculum at the end of the year.

G. Discussion Items

- a. Corporate Sponsorship Proposal Brianna McGillis (Fundraising Committee)
 - Hoping to raise additional 5 to 20K for staffing budget
 - OC is a Title I school (35% of students qualify for school lunch), so we can really use additional funds that don't come from families

Needs: - Another person in library, full-time music teacher, administrative staff

- Could also use more Before/After school staffing unique need for OC as a commuter school
- Reading curriculum will cost up to 50K at the end of this year
- Get up to a 1:1 computer ratio in classrooms

Incentives needed for corporations – packages proposed for sponsorship levels

- name and logo recognition at different events and on flyers

 Platinum would also have banners displayed at school in Sept and May, our biggest fundraising months

Unsuitable Businesses - List of companies whose main products cannot be brought into the school, or break the dress code if advertised on clothing

- There is a process to add a business to the Unsuitable list (see slides).

Maile: This money would go into General Funds, since PFOE funds can not be used for certain things.

- We especially need money for salaries, which must be in General Funds.
- Please take this back to classrooms to discuss and get input. In Feb. we will discuss further and take a vote.

Brianna: We have 3 lists of companies to approach.

- Length of contract? One school year. But we will be asking throughout the year, and companies have their own schedules for when they give donations.
- We would try to figure out the best month, and approach them once a year, in the month they were last approached.
- How long does it take to get money from the companies, from experience with other schools? 2-4 weeks, sometimes 6. They usually want to pay us quickly.
- We'll start this year as soon as it gets approved, but how will it be done in future years? We will ask companies all throughout the year.
- How do we add a company to lists for approach? We are still setting up lists.

Maile: Take this back to the classes! Email us as you get questions, so we can prepare answers for the next meeting.

H. PFOE Budget Report - Maile

- Finally got report from district! They are short-staffed
- Final Walkathon Revenue is \$15,771.68 Wonderful!
- Solstice Sales earned \$320

Aileen: Proposed District 3-year Calendars:

- Last month, the Steering Body had a preference for Option 2 (with 1-week Fall Break)
- In our SCC meeting last month, we found out the teachers prefer Option 3 (5 teacher preparation days at beginning of year, 2-day Fall Break, and school year starting a week earlier in August and ending in May.) The teachers really want preparation days at the beginning of the year.
- We voted to recommend Calendar Proposal 3 to the District.
